## CONSTRUCTION OF NEW SPORTS FACILITIES IN BARFORD TO COMMENCE AS FUNDRAISING TARGET REACHED

After just 18 months of raising money, the dream of new sports and recreational facilities on King George's Playing Field in Barford will soon become a reality thanks to the £450,000 fundraising target being reached in late August.

WREN, a not-for-profit business that awards grants for community, biodiversity and heritage projects from funds donated by FCC Environment through the Landfill Communities Fund, has recently awarded £50,000 towards the project. Combined with a substantial contribution from Warwick District Council and an additional £20,000 raised from Barford, Sherbourne and Wasperton villagers, the fundraising target to build the facilities has been achieved. Whilst additional fundraising will continue to raise money to purchase equipment, the realisation of this milestone has enabled contractors to be appointed with work due to commence in early September. The facilities are expected to be completed, and ready for use, in December having also had grants locally totalling over £80,000 from Barford Community Charity and Barford St.Peter's School Trust.

A working group was formed two and a half years ago to plan how to raise enough money to bring in an exciting new children's play area, as well as create a multi-use games area (MUGA) including two tennis courts and an all-weather court, picnic and toilet facilities and an upgrade to the lane accessing the site. Villagers also requested the introduction of pathways around the playing field and additional seating, both of which are being implemented.

The fundraising news was announced to locals by members of the working group at a summer fun day held in Barford on bank holiday Monday (31 August). The event, which attracted over 200 people who defied the wet weather to turn out and support, was opened by guest of honour Karen Carney, captain of Birmingham City in the Football Association Women's Super League and also a member of England's national football team. It was hosted by Sarah Falkland from BBC Midlands Today, and the many activities on offer included a Barford Bake Off, a Barford's Got Talent contest and a Barford Pets with Talent contest. The fun day raised a further £6,000 on a wet bank holiday Monday.

John Murphy, Chairman of the Barford, Sherbourne and Wasperton Joint Parish Council and member of the working group, said "It is simply breathtaking to see just how far members of this working group, in partnership with residents from across Barford, Sherbourne and Wasperton, have progressed in the last 18 months. To have finalised the scheme design and raised such a significant amount of money in such a short period of time is outstanding, and I am so proud of what our local community has achieved. The latest grants from WREN and Warwick District Council are major milestones for us as they enable the project construction to finally begin. This is proof that with

belief, dedication and energy, dreams can become a reality. I speak on behalf of residents from across the three villages when I say that I cannot wait for the new sports facilities to be opened towards the end of the year."

This sentiment was echoed by Councillor Peter Whiting, Portfolio Holder for Finance at Warwick District Council, who commented "The amount of community effort which has gone into the fundraising work since this project commenced is amazing. Given this, Warwick District Council has been delighted to support such a proactive approach. I personally applaud those who have invested considerable time in this project and I share their excitement in looking forward to seeing their hard work rewarded with new sports facilities fit for future generations of local villagers."

Joe Newby, WREN's grant manager for Warwickshire, says: "We're delighted to be supporting the Kings George's Playing Field Improvement scheme and pleased our funding will provide such a fantastic facility for the people of Barford and surrounding communities. WREN is always happy to consider grant applications for projects that make a difference to local communities and we're really looking forward to seeing this one take shape soon."
